A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF QUARTZSITE, ARIZONA, ESTABLISHING AND ADOPTING ADDITIONAL FEES TO THE PREVIOUSLY ADOPTED FEE SCHEDULE IN RESOLUTION 23-08, TO INCLUDE ADDITIONAL FEES FOR SPECIAL EVENTS; PROVIDING FOR REPEAL OF CONFLICTING RESOLUTIONS; AND PROVIDING FOR SEVERABILITY

WHEREAS, on December 12, 2023, the Mayor and Council adopted an annual fee resolution, Resolution 23-08, setting forth the various fees charged by the Town of Quartzsite; and,

WHEREAS, the Town has established additional fees for special events purusnat to Town Code and desires to update the Town's fee schedule with these additional fees.
