READING & APPROVAL OF MINUTES:

Vice Chairperson Lynn Stimson motioned to approve the Hi Jolly Cemetery Board Minutes taken May 2, 2016. Board Member Art Larsen seconded the motion. The motion passed unanimously.

BUSINESS:

1. Annual nomination and election of a Chairperson.

Vice Chairperson Lynn Stimson motioned for nominations to be closed and leave Bruce as chairperson and Board Member Dee Sheehan seconded the motion. The motion passed unanimously.

2. Discussion and possible action to accept the offer made by Quartzsite Business Chamber to host, produce, present and facilitate a "Cemetery Walk" at the Hi Jolly Cemetery on February 18, 2017.

Joanne Winer presented the Chamber of Commerce adaptation of their "Historic Pageant" that they would like to put on at the cemetery on February 18th, 2017. Vice Chairperson Lynn Stimson would like Joanne to present this to the Historical Society. Dinice Ross will provide any material that she has available from the past Cemetery Walks. Board Member Audrey Berger moved to accept the Chamber of Commerce's offer and Board Member Art Larsen seconded the motion. The motion passed unanimously.

- b. The storage unit had been moved to the cemetery.

- c. The cremation wall was scheduled to be painted once the weather gets cooler.
- d. Bruce would like to see a discussion of a new memorial wall on the next agenda.

2. Report on the need for Community Service Workers

Dinice Ross would like to have some community service workers to start to clean up the washes. Vice Chairperson Lynn Stimson said the Youth Council may like to help out with some of the projects. Jim Ferguson said they would need the proper gear for projects.

3. Report on solar lights at the entrance wall.

Dinice Ross reported that some of the solar lights, at the entrance wall, are damaged and may not work. Chairperson Bruce Swart said the far right and middle are sort of working, but they all looked mangled.

4. Report on placement of headstones for indigents.

Dinice Ross updated the Board that she is waiting to put out the headstones until the inner roads of the cemetery have been graveled.

Board Member Audrey Berger is resigning from the Board. She will be here for one more meeting.
