Waste water report on billing for the year of 2012-2013 and 2013-2014 provided by Rondus Bennett.

Rondus Bennett gave a report of the Wastewater billing comparison of 2012-2013 and 2013-2014.

The total difference in billing was \$243,732.28 more in fiscal year 2013-2014 than in fiscal year 2012-2013.

Committee Member Richard Thompson asked what is being done for those who use water for irrigation in regard to their sewer rates. Rondus Bennett responded by saying the Utilities

Department cannot differentiate irrigation usage from other usage. She said the department is looking into that issue.

Rondus Bennett explained the difference between the new and old water base rates and wastewater base rates.
