1. **Approve Minutes: January 17, 2014, February 18, 2014, and March 7, 2014.**
Reschedule the approval of the minutes due to the minutes being incomplete.
2. **Review Article IV of the Zoning Articles for clarification on Zoning Districts. Possible action to recommend amendments to this article.**
Motion to change the format, Commissioner Frausto motioned to wait to receive the matrix from Mark on the restructuring of the information of the zoning districts, Commissioner Hearne seconded the motion, all voted Aye. Motion carried. R2MR-Zoning District. Recommended Zoning Article amendment. Removing 'Minimum Under Roof Area Per Dwelling Unit of 3,000 Square Feet On A Minimum Lot Area of 6,000 Square Feet' from the wording of the zoning district. Commissioner Frausto motioned to amend Article IV, Paragraph 6 and Commissioner Kuehl seconded the motion, all voted Aye. Motion carried.
3. **Review Article X, Section 2, Paragraph 2 of the Zoning Articles which pertains to Conditional Use Permits. Possible action to amend the Article to read: 'Every Conditional Use shall run with the land. It shall be the responsibility of the property owner to comply with the special conditions imposed on the Conditional Use; as well as to comply with all applicable provisions of the Town Code, as long as the use exists.'**
Motion to accept the revision of conditional use terminology by Commissioner Kuehl and Commissioner Hearne seconded the motion. All voted Aye. Motion carried.


