BUSINESS

1. Discussion of new Memorandum of Understanding with WACOG concerning new fare structure for Ticket Program. Transit Coordinator Janet Collier discussed the new MOU with WACOG the new MOU addresses the new 5311 changes to our fare structure establishing fares as one way. Ticket value will be based on where the ticket is used. One ticket to board one ticket to final destination and a ticket for every stop in between. New MOU was reviewed by town attorney, and adopted by the town council August 22, 2016. Originals were signed by new town manager and sent to WACOG for their director's signature.
2. Discussion of certification eligibility forms for discount fares.
Transit Coordinator Janet Collier discussed the need for the form, asking the TAC members to review 3 different forms and pick one to adopt at the next TAC meeting. Monica proof reading one of the forms and requesting staff make grammar correction having the form corrected and ready to vote on at next meeting.
3. Board Discussion of Community input since July 1, 2016
Transit Coordinator Janet Collier discussed the input from the public. Trips to Lake Havasu and Yuma working well. Our passengers are not happy with the Blythe service because they have to change busses and ride a fixed route system as opposed to having curb to curb service. They are unhappy about waiting at a stop for pick up with packages and groceries Vice Chair Dave Collier suggested a person be available to assist our riders to navigate the Blythe transfer situation. Janet reported our drivers are working with the Blythe drivers to assist customers with destination stops and schedules. Discussed looking for a volunteer to ride with our sight

challenged passengers to assist them to navigate the Blythe system. Current volunteer relocated out of area.


