On Sunday, May 31, 2015, in the morning hours around 8:00 AM, Quartzsite Police Department (QPD) was called to the scene of a fight where a male and female were stabbed by another male suspect at large in the Cactus Patch Mobile Park located at 150 East Cowell Street in the Town of Quartzsite, Arizona. This information was provided to the QPD from the La Paz County Sheriff's Office dispatcher via 911 caller. QPD Sergeant Frausto arrived on scene and observed numerous individuals. A male victim was bleeding with a single stab wound to the lower back area. A female victim received minor cuts from the suspect's knife. The Quartzsite Fire Department was dispatched to the scene where the stabbing victim was airlifted to the West Valley Hospital in Phoenix with serious injuries. QPD learned from witnesses that a disagreement and fight started when the landlord's employee served an eviction notice to a tenant named **Roy Lee Barnhart AKA: Waterboy Roy**. Witnesses observed the fight between the two individuals and they identified **Roy Lee Barnhart AKA: Waterboy Roy** as the person who stabbed the male and female victims and fled from the scene. Chief Renfro assigned Detective Hilario Tanakeyowma to conduct a follow-up interview with the victim at the West Valley Hospital in Phoenix and obtain his medical condition. The Quartzsite Police Department has processed the small scene by gathering evidence and witness statements. QPD worked late into the night attempting to locate the stabbing suspect **Roy Lee Barnhart AKA: Waterboy Roy**.

The Quartzsite Police Department is requesting assistance from the community with locating **Roy Lee Barnhart AKA: Waterboy Roy** described as 62 years of age, height 5'11", weight 175-195 lbs., blue eyes and grayish-brown hair. QPD has information he is hiding out in Quartzsite and possibly in dry washes. We have information he may attempt to leave the Town of Quartzsite by vehicle or bus.
